Robin Hood Multi Academy Trust works closely with Birmingham City Council and each school has aligned their Safeguarding Policy to that of the Birmingham Safeguarding Children Board. Robin Hood Multi Academy Trust will ensure all policies linked to the safeguarding of children are up to date and in line with Keeping Children Safe in Education. The policies are accessible to all staff on Google Docs and through the school websites. Policies and procedures are reviewed and revised regularly by the Trustees of Robin Hood MAT.

Each school within Robin Hood Multi Academy Trust:

- 1) Completes an annual internal safeguarding audit and addresses any highlighted areas for further development.
- 2) Is externally audited by an objective safeguarding professional outside of the Trust and addresses highlighted development points.
- 3) Has their Single Central Record reviewed on a half termly basis.
- 4) Attends the MAT DSL safeguarding meeting on a half termly basis and cascades information down to deputy DSLs and the wider staff.
- 5) Provides a half termly safeguarding report to the Executive Board of Trustees - this is then scrutinised rigorously analysed.
- 6) Lead DSLs attend regular safeguarding meetings and training held by the Birmingham Children Safeguarding Board.
- 7) All DSLs within the Trust take part in frequent supervision meetings.
